

2010 BUSKER: FEE APPLICATION
St. Albert Chamber of Commerce Outdoor Farmers' Market

The 2010 Farmers' Market is scheduled to run from June 19 to October 9, 2010. **Market hours are 10:00 a.m. to 3:00 p.m. and this is a rain or shine market.** Previous participation does not guarantee acceptance. All applications are subject to review and approval by the Farmers' Market Committee.

BUSKER POLICY: Busking is a privilege that is meant to enhance the market environment. Busking should never interfere with vendor/customer transactions.

THEREFORE:

1. Buskers must check in at the Chamber booth no later than 9:45 a.m.
2. Buskers are required to stay at the Market from 10:00 a.m. until 3:00 p.m.
3. Buskers will be assigned their allotted space in the market by market administration.
4. Buskers will be required to display approval button (entertainment button).
5. There shall be only one busking group within listening distance.
6. Buskers may receive donations
7. Should a Busker create a problem (i.e. noise, traffic concerns, inappropriate behavior, etc.) as defined by the Farmers' Market Manager, the Busker shall agree to abide by the decision of the above mentioned person. The Market Manager's decision may include having the Busker re-locate immediately, or, should the problem be un-resolvable, to have the Busker's opportunity to busk revoked and to disallow the Busker on the market site, no refunds will be issued for non-usage or expelled Buskers.
8. If you are unable to attend the market you must give the Market Administration a minimum of 48 hours notice by calling the office at **(780) 458-2833**. In the event of an emergency call the Market Managers' cell phone at **(780) 977-1272**. For any unforeseen circumstances that happen during market hours please see the Market Manager.
